Minimum Payment: Visa Business Card: The sum of (1) any amount over your Credit Line and (2) the greater of \$10.00 or 2% of your Account balance.

Variable Rate Based on the Prime Rate: Variable APRs are based on the 8.50% Prime Rate as of July 27, 2023. The APR may increase or decrease monthly if the Prime Rate changes during that period, but will never exceed 25%. If an APR increases, the amount of interest and the minimum payment may increase and may result in a smaller part of your payment being applied to reduce principal. If The Wall Street Journal ceases publication, we will select a new index and notify you of the change.

Purchase and Balance Transfer APR: Visa Business Card: We add a Margin of 6.74% to the Prime Rate of 8.50%. Visa Business Reward Card: We add a Margin of 8.74% to the Prime Rate of 8.50%.
